3. Financial Solvency

- The Association's 2018 audit was clean & contained no material findings of concern, nor recommended changes.
- Revenues for the Association should exceed \$31 million for RESPECT & membership for this fiscal year.
- Membership revenues were at about \$600,000.
- The Association's operating budget was about \$2.4 million.

- The Association lives within its budget and is healthy. Revenues and expenses are monitored closely.
- The Finance Committee met quarterly and the Governing Board of Directors met 3 times.

5. Forum Deliverables

- Florida ARF serves as the Central Nonprofit Agency that manages RESPECT of Florida, under a 6% CNA fee.
- The RESPECT Oversight Committee (ROC) met quarterly to ensure adequate program oversight.
- RESPECT facilitated employment opportunities for about 1,200 individuals with severe handicaps. RESPECT sales will come in at above \$31 million for the FY.
- Average hourly wages earned were \$9.49. Most jobs performed at integrated sites.
- About 50 RESPECT nonprofit agencies are certified to produce commodities and service contract work produced by individuals with disabilities for state & local government.
- RESPECT funded two micro-enterprise grants for \$12,500 to promote self-employment of individuals with disabilities.
